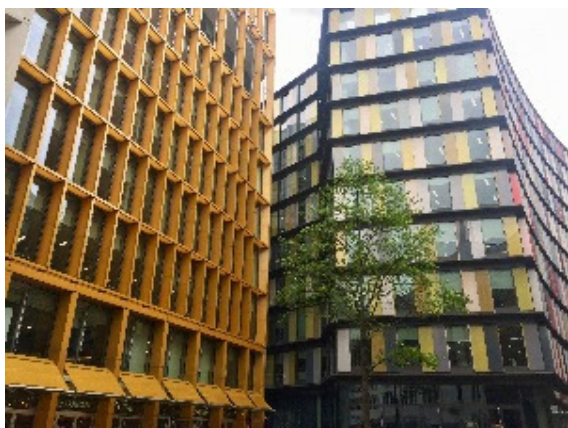

Courts on 14 January 2019, MOJ has launched a **consultation** in relation to **extending** the use of **Fixed Recoverable Cases (FRC) in Civil Cases**. This follows recommendations made in Sir Rupert Jackson's Supplemental Report on FRCs in July 2017.

The consultation is seeking interested parties' views on the extension of FRC to (1) fast track cases and (2) intermediate cases being cases valued between £25,000 and £100,000.
